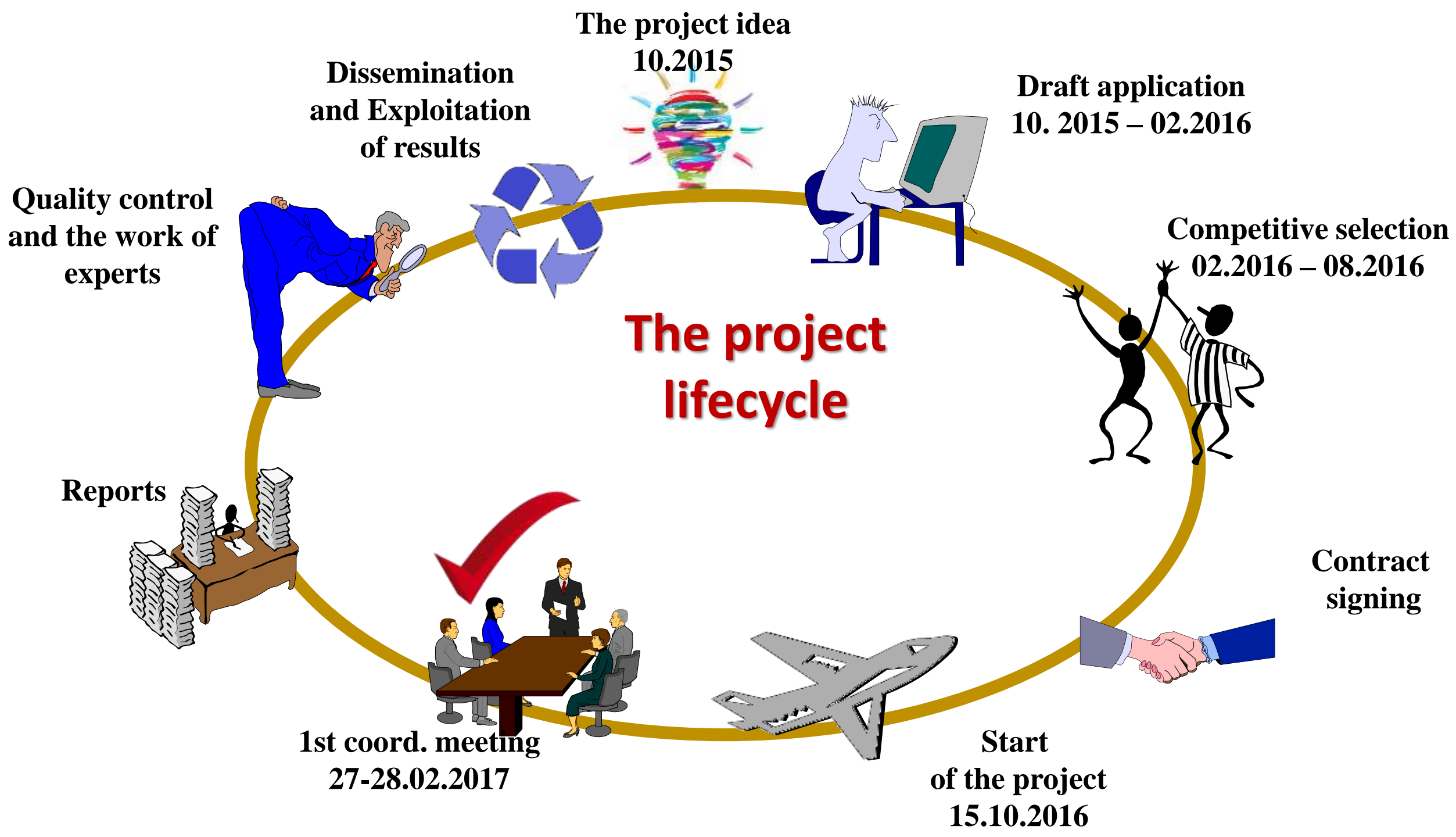

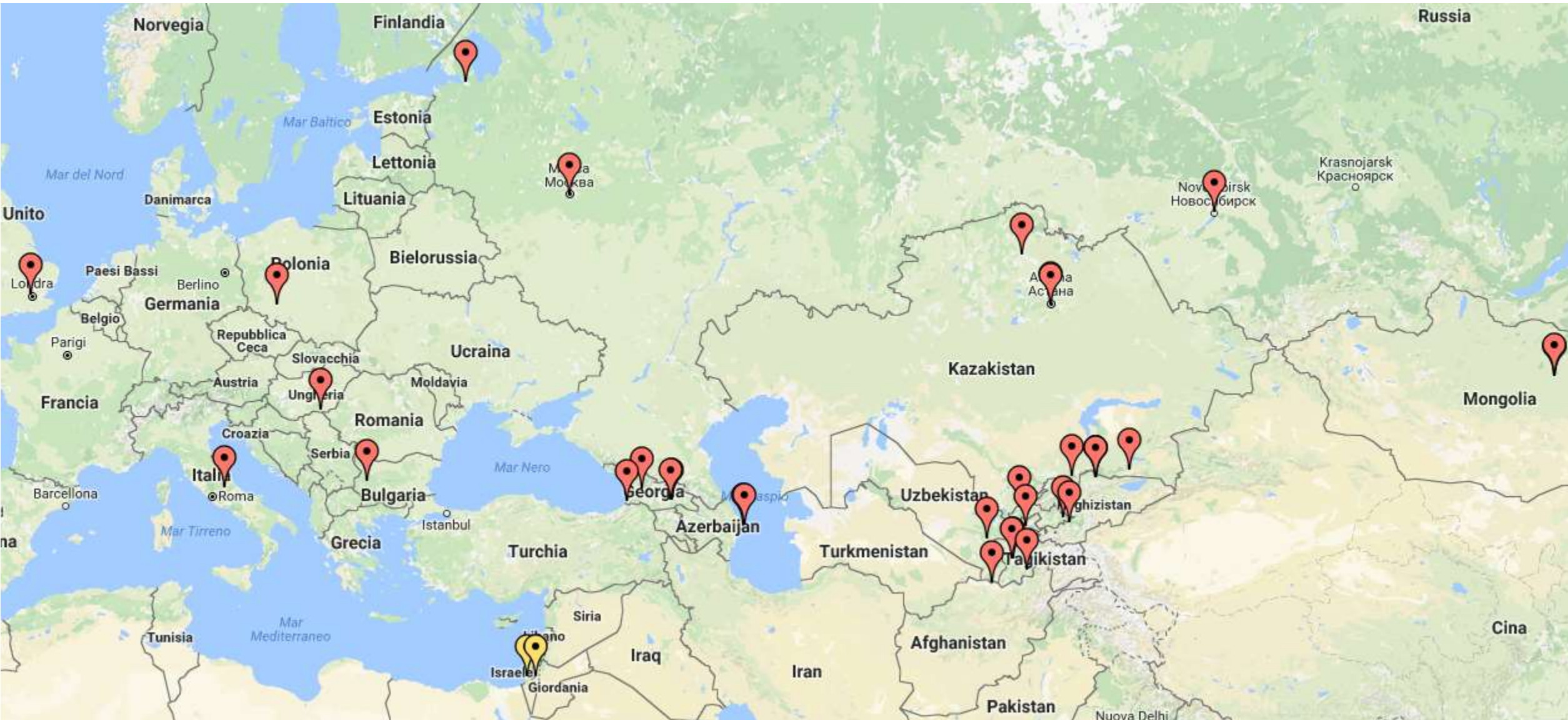

To implement concrete pilot examples and compare students' performances

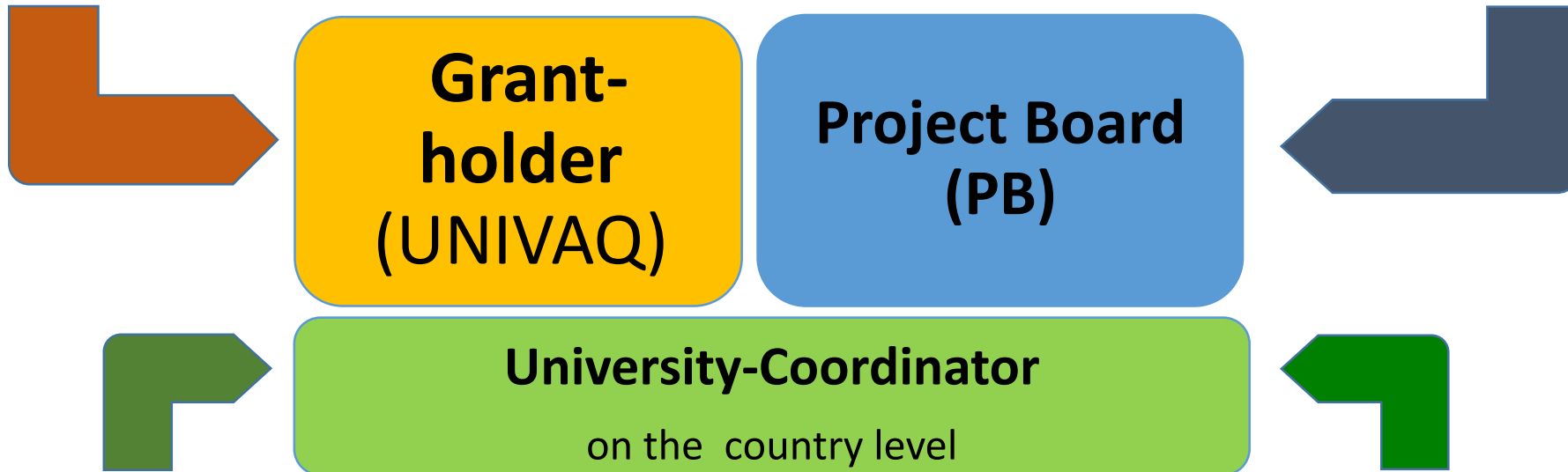
To foster the “Credit Mobility” participation and the inter-institutional cooperation

Project management

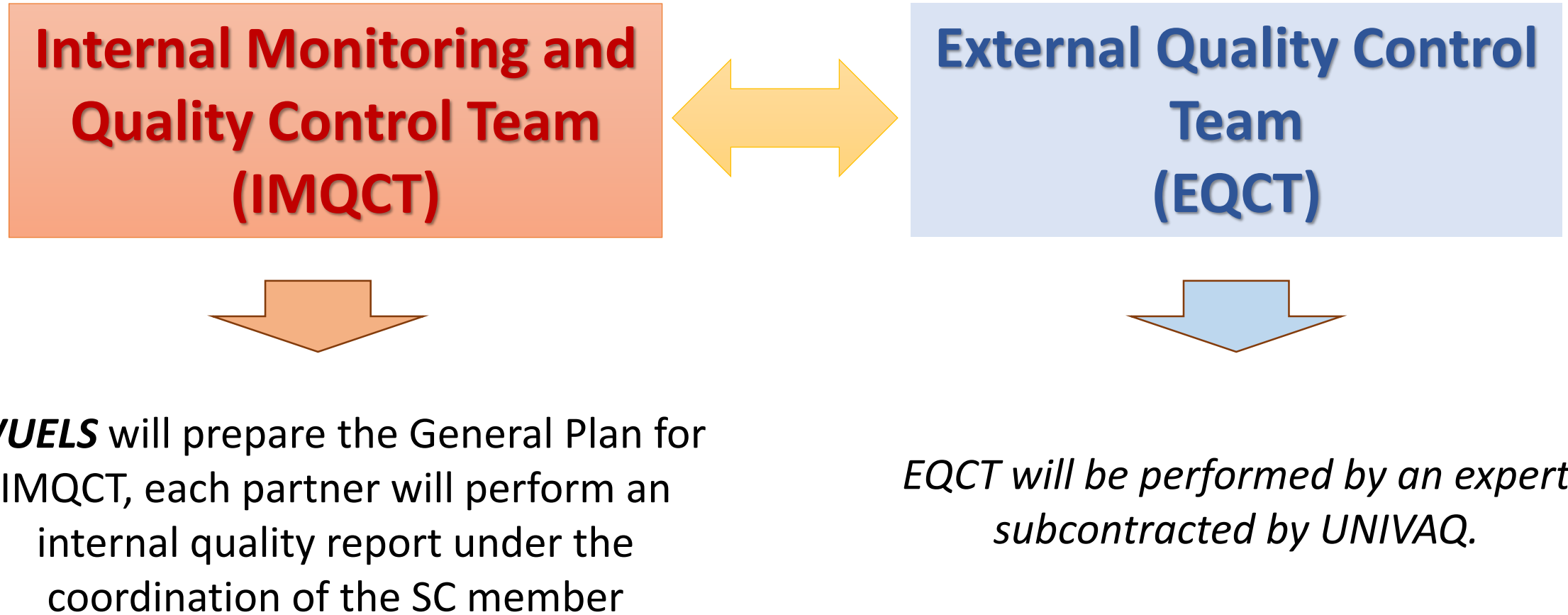
Decision making process should be done jointly, but in case of conflict the Grant-holder will have the right of final decision. Current project management and financial management will be in the responsibility of the Grant-holder.

Project Board (PB): include representatives of all the partners in the project (project managers in each university). The composition of the PB will be determined at the first meeting in Wroclaw.



One university in each country, which should be selected on the kick-off meeting. This university will be in charge for collecting reports, coordination of trips and general management with the Grant-holder on behalf of other universities in the country.

Quality Assurance and monitoring



WP1: Data collection (Preparation)

1.1. Share of information on the 13 (5EU and 8PC) Framework of Qualifications, credit systems, level of application of ECTS system.
